Discussion/Continuing Projects

MJC Graduation Ceremony - Iris Carroll

We've outgrown the stadium's capacity. We're talking about splitting the ceremonies. They need feedback by Monday, January 22. Some ideas: Two the same day; one in the fall, one in the spring; organize by School. Secondary issue: The workload has fallen on Student Services and Staff. What is a more equitable distribution of labor?

BG: Is the expectation that faculty would attend multiple ceremonies?

IC: If it was broken up by Schools, then faculty would just go to their own School's.

Laura DeLeon: She likes the idea of Schools.

BG: At Columbia, they have a variety of graduation ceremonies.

Ben Riley supports separating it by schools. Counselors might need to go to ALL the events, though.

Amy: In Child Development, like Nursing, we already have separate ceremonies.

Erin Black: Would we have multiple keynotes, or they repeat their address?

OO: How would we schedule multiple ceremonies to allow for access to families to see their grads walk.

Iris: Since this is split, how do I vote? NO.

• Stipends/Professional Time - Brian Greene

Stipends are quite a can of worms across the District. Roughly 30% of our salaries are for professional duties (prep, grading, committees, college-wide work, etc.). We have an MOU that establishes how PTers are paid for work that FTers get paid for as part of their salaries. We also pay out a HUGE amount of money in stipends. We're working to make sure they're all consistent and fair. Brian has a list of all of them, and now we're going through them. In the fall, there were hundreds of thousands of dollars in stipends. This might then establish the expectation that there should be a stipend when a certain duty or task could be considered a professional duty. If anything, we need to remind faculty that we get a good chunk of money for doing professional duties. If anyone has ideas about how the issue of stipends could be addressed.

Allan: The challenge is where to draw the line. If training is required for some but not others, then a stipend seems in order.

BG: HR is not checking up on these stipend agreements once a dean offers a stipend. YFA is trying to establish a reasonable process for evaluating them.

Tim Elizondo: Another issue in the past was that stipends varied in amount for what appeared to be the same work (just on different campuses). Can use this extra work (that everyone is doing) as a bargaining chip in negotiating higher salaries.

BG: As of the Fall 2023 semester, there were 118 instances of the District direct dealing with faculty, that is, not involving YFA in determining the stipends. We're moving the right direction, however, in creating a process. If anyone is frustrated with their stipend, then they need to contact us.

In Sports, the stipends are codified for the FTers. There might be variability for the assistant coaches who are brought in from the outside.

Action

- Conduct Special Election for Columbia Vice President/Grievance Officer
 - O Nominations: Derrick Wydick

Motion to approve: Pam G-S; seconded: Tim Elizondo. Vote: Unanimous. Abstention: Derrick Wydick. The term goes through Spring 2025.

- Conduct Special Election for MJC Member-At-Large
 - O Nominations: Erin Black

Motion to approve: ben Riley; seconded: Steve Choi. Vote: Unanimous. Abstention: Erin Black. The term goes through Spring 2025.

This creates two vacancies for Derrick's and Erin's old roles, so we need to find people who can serve.

- President's Report Brian Greene
 - o Dues

The bylaws require us to review our dues. Next week at Exec, we'll start discussing this, and then it'll be an agenda item in February Rep. We need to decide by March if we're making a change since it would have to go out to faculty for a vote.
