Discussion

Guest: YCCD Area 4 Trustee Jenny Nicolau. Introduction and Q&A

In her self-intro, Trustee Nicolau stressed that in joining the YCCD Board, she doesn't have an agenda. Based on her experience on the Almond Board of California, her full-time job, she wants to do what's right for the District. She wants us to get our return on investment for the money we spend. And she likes to ask hard questions.

Brian Greene asked: How do you get constituent feedback?

JN: Some Board members are more plugged in, but most trustees get feedback in the public comments at board meetings and/or from the Executive team.

BG: One issue is that YFA gives it report *after* closed session, but the Board discusses YFA issues *in* closed session. JN: When we hear public comment, we cannot respond, which makes it hard. Also, what the Board doesn't hear is the good stuff, in general, and/or anything about or from students. They mostly hear about negotiations.

Allan McKissick: Regarding accessibility, he's glad that JN is here, but it would be nice if there was more interaction between the Board and faculty.

JN: She doesn't see any problem with having open conversations with faculty, students, etc., but the rest of the board might not be so open. Also, it's possible that someone can call me, but I might not be able to respond.

BG: We have a lot of admin who are interim, which is hard for the institution. What are your thoughts? JN: It's ridiculous. But it's also hard. The Board only has one employee, and that's the Chancellor. Therefore, we don't have a role in leadership choices.

• 50% Law in the Spotlight - Brian Greene

The 50% Law requires that more than 50% of the general fund must be spent on instruction – faculty, faculty support, etc. Librarians are NOT counted.

In our District, general apportionment is about 116 million, which means 58 million goes to instruction. We're at 50.01% (\$10K over). This is not uncommon. Most schools are close to the 50%.

Side note: The total District budget is 159 million; 58 million is 37% of that.

At DFAC, we asked Trevor Stewart if there is a similar requirement for classified staff, admin, etc., and he said that they determine that based on 50%.

There might be a move to change the 50% Law, in which case we'd need our leadership to advocate to at least keep it. It's conceivable that they could raise it to, say, 53% and then include non-instructional faculty. One member asked, "What is FACCC's view on this?"

BG: FACCC is concerned that changes can be made to increase admin salaries and other non-classroom or faculty expenses.

Action

YFA Bylaws Revision Update - Optimism One, Pam Guerra-Schmidt & Dimitri Keriotis

Op walked us through the most recent changes.

Theresa Stovall moved to forward the revisions to the membership for ratification. Dimitri Keriotis seconded it. Pam Guerra-Schmidt: Should we split the vote? Vote separately for the reassigned time and then everything else? Theresa asked to include a friendly amendment: Article 3.6 Non-discrimination: Can we add religion? Pam: Another friendly amendment: 11.9.2 other exec board vacancies — open to anyone in the membership — but change to "respective colleges"

So now, with the above amendments, Theresa moved to vote. Pam seconded.

Vote for everything (except reassigned time): Unanimous.

Vote for changing reassigned time for CC from 50% to 40%: 18 in favor; 2 opposed; 1 abstention.

A ratification ballot will be sent to all YFA members that will include a summary of the recommended changes with the complete document attached.

Announcements, Updates, Reports, and Other Business

- President's Report Brian Greene
 - Stipends

Currently, there are about 160 stipends. 100 of those have been negotiated directly between District and faculty members without YFA approval. YFA is contractually required sign off on ALL of them to make sure the deliverables are clear, a fair process for choosing faculty has been followed, etc. For Part-Timers, stipends don't contribute to 66%.

o Rehire Points Process for PTers

We're working toward a resolution to Article 7 in the CBA to make it as clear as possible. Currently, the District has a different interpretation of Tier B.

Holidays

Update on the status of two new college holidays: Native American Day (in September) + Cesar Chavez Day (in March). We'll need to pay close attention to scheduling, especially for Monday classes.

o FLEX and Vision Resource Center

BG met with Amy Carnahan-Cook and Rob Stevenson. Maybe we can use more of VRC and make it all better for everyone. Let Amy know if you have any ideas.

Banked Leave

Our leave report at the end of the month SHOULD include banked leave from now on.

Of the two people Brian has examined, BOTH were wrong.

BG's ask: If it's on the ledger at the end of the month, talk to faculty to see if their reports are accurate.

A Rep asked: How will I know if it's correct or not?

BG: Ideally, each time one banked would be evident. Some digging might be necessary, but if one does a gutcheck on whether it's right or not, start there. If there's something wrong, contact Brian G, Steve C, or Craig J.

Lawmakers

BG trying to schedule meetings with local lawmakers so we can advocate for CCs. If anyone wants to join Brian, let him know.

He's working on multiple violations of Article 7, which might end up being a PERB filing. In addition, there is plenty more that's keeping him busy, including at Columbia.

In Shelley's absence, BG reports: We're working to resolve several articles. We've been approving each article individually and the membership will ratify them at the end of the round. With benefits, we signed an MOU to make sure faculty were covered immediately.
